MINUTES  
November 10, 2014**

The meeting was called to order at 7:24 p.m. by President, Elizabeth Mendelman and the Pledge of allegiance was recited.

Present at the meeting were the following individuals:

Elizabeth Mendelman, President, Tim Frazier, Jeffrey Miller and Adam Wilson, Trustees. John Grant was absent from this meeting. John Finello, Superintendent, Thomas Primiano, Treasurer, Eric Casale Principal and Frances Silipo, District Clerk and fourteen people in the audience including two members of the press.

A motion was made by Jeffrey Miller, seconded by Adam Wilson and the following resolution was approved:

Be it resolved that the Board of Education hereby approves the minutes from the monthly meeting held on October 13, 2014.

Mrs. Matz shared the monthly PTA report. She encouraged everyone to join in the upcoming Turkey Trot to raise funds for the PTA. The student participants are being sponsored by family members and friends to participate.

Mr. Casale shared a power point presentation on scheduling. This led to some questions about the periods in a day and space needs within the building.

Mr. Casale reported that enrollment showed 31 students attending the Charter School up from the 19 previously, which is a budget impact.
