

### TERMS AND CONDITIONS

1. As the Responsible Party, I understand and agree that I am solely responsible for payment of all rink/court rental charges, and that payment in full must be made prior to using my rink/court time.
2. I understand that I must provide SPORTIME with a valid credit card or a cash deposit in advance of any reserved rink/court rental.
3. I understand that if I cancel my reserved rink/court time less than 24 hours in advance of the start of such reserved rink/court time, or do not show up for my reserved time, I am responsible for the full cost of the rink/court time reserved. In addition, in such circumstance, if I have not made payment for my rink/court time, I hereby authorize SPORTIME to charge the credit card I have provided to SPORTIME in order to confirm my rink/court time reservation.
4. I understand that I am responsible for full payment of the reserved rink/court rental even if, at the time of the rental or within 24 hours, I decide I may not need the full space. For example, if my group would like to use only 1/3 or 2/3 of the Arena but I have reserved the entire Arena space, full payment of the Arena space is still required.
5. I understand that the use of the rink/court beyond the contracted time will be subject to additional charge, for which I am responsible.
6. I understand that SPORTIME reserves the right to terminate this agreement at any time for unsportsmanlike conduct on the part of any rink/court user, or for any other reason deemed reasonable by SPORTIME management.
7. I understand that each individual who participates in my reserved rink/court time must sign a Liability Waiver/Assumption of Risk and Release form prior to participation. I further understand that if any participant in my reserved rink/court time is a minor, then such minor's parent/legal guardian must sign the Liability Waiver/Assumption of Risk and Release form, on his/her behalf, prior to participation.
